WELCOME!

We are pleased to see the onset of spring and the promise of warmer days. At the same time, we know most of the village is preoccupied with the future of Hamble Airfield and the current planning application to quarry sand and gravel from the site.

On Monday 28 February, Hamble Parish Council hosted a public meeting to discuss the application. We heard presentations from Hampshire County Council (HCC) as the Planning Authority, Eastleigh Borough Council, and the planning consultant the parish has appointed to assess the application. We were also delighted to welcome Paul Holmes MP, Councillor Rob Humby (Deputy Leader of Hampshire County Council), Mr Alaric Govan (Headteacher from The Hamble School), and Dr Mark Tomson (Senior Partner from Blackthorn Surgery).

The speakers' presentations and public questions were focused on concerns around: congestion, air quality and road safety and the duration of works for three generations of school children in the village. Concerns were raised about the impact of quarrying for neighbours in close proximity and the potential impact on residents' health. Questions were also raised about the 'aftercare period' for the site, and how would Hampshire County Council ensure the proper management of the site for long enough. Suggestions included: the use of bonds, planning agreements and consideration of designating the site as a village green. Residents also asked how demand can be switched from quarrying for aggregates to recycling and reuse, and what steps can government take to move the construction sector in this direction.

ON TIME AND IN BUDGET! OUR COMPLETE FORESHORE BENCH PROJECT

The project to replace 16 benches at the Foreshore is now complete – in good time for Hamble residents and visitors to enjoy as the warmer weather returns.

All plaques that were on the previous benches were removed and will be placed on a new plinth for families to visit.

The project was completed on time and within budget, with our partner on this project, local company Wren Construction. They delivered more than was originally quoted, including: the addition of raised borders, topsoil for all three beds, and the donation of 600 bulbs.

Our thanks to Eastleigh Borough Council who contributed £40,000 towards the benches and a further £2,445 for the planters and plants.

There will be an official opening and ribbon cutting as part of the Platinum Jubilee celebrations. In the meantime, please enjoy the benches, and let us know what you think – we'd love to share some of your photos on Facebook and in future newsletters.



HELP US TO KEEP OUR PATHS CLEAN

Many of you have reported that there continues to be an issue with dogs messing in the village and by the benches on the Foreshore.

Dog mess is the most unacceptable and offensive type of litter on our streets. It is not only unpleasant but can be dangerous. Whilst rare, contact with dog excrement can cause toxocariasis – a nasty infection that can lead to dizziness, nausea, asthma, and even blindness or seizures.

GRANT AWARDED TO HAMBLE CONSERVATION VOLUNTEERS

The Parish Council has awarded a £500 grant to Hamble Conservation Volunteers to help them fund items including hi-viz vests, litter pickers, gloves, and saws. The volunteers do a fantastic job helping to maintain and look after our village through: 'beach cleans' and maintaining trees, hedges, heathland, and Hamble Common.

FUTURE OF HAMBLE AIRFIELD: WHAT YOU NEED TO DO

WHAT IS CEMEX PROPOSING?

- Cemex plans to extract up to 1.69million tonnes of sharp sand and gravel from Hamble Airfield
- Up to 144 lorry movements per day on Hamble Lane
- A new quarry entrance will be located between both schools on the east side of Hamble Lane opposite the Police headquarters
- 'Quarry activity' will be as close as 40 metres from certain homes
- Once the quarry closes, Cemex intends to restore the site to grazing and parkland, with a small area for public access
- All HGVs accessing the site will travel along Hamble Lane and over Hamble 'Halt' railway bridge.
- This entire process is likely to take up to 14 years to complete

HOW WILL THIS AFFECT YOU AND YOUR FAMILY?

Traffic implications and road?

- Do you think the proposals will influence traffic on Hamble Lane? If so, how? Will extra HGV vehicles put you off walking or cycling on Hamble Lane?
- Would you be concerned for your children walking or cycling to school?
- If buses are regularly delayed (including college buses) how will this impact your family?

For your home?

- How will the operations of the quarry impact the way you enjoy your property and garden?
- Should the *buffer zone be bigger? (*i.e. the gap between your property and the quarry site)
- How will working on Saturday mornings disturb you?
- Do you believe the quarry will have an adverse effect on air quality?

For water management (hydrology)?

- Are you concerned that quarrying on the Airfield will increase the risk of flooding, water run-off or subsidence? Why are you concerned about this?
- What water management controls would you like to see put in place?

For recreation?

- Are you a regular user of Hamble Airfield for recreation (e.g. walking your dog)? Where would you go instead and what could be the impact of this on other sites?

For the environment and biodiversity?

- Do you believe there is enough protection for existing ecology on the site and surrounding area? Are the proposals for securing biodiversity after extraction adequate?
- Do you want more public access than being proposed after quarrying has finished and who should manage the site afterwards?

HOW TO MAKE A GOOD REPRESENTATION

If you're thinking of sending in an objection to the Cemex application, we'd suggest that you follow these simple principles to make it as effective as possible:

- 1. The principle of gravel and sand being extracted from Hamble Airfield was decided back in 2013 by a Planning Inspection at a Public Examination. Although you might disagree with the decision it is counterproductive to raise this issue now or to suggest alternative sites. We need to focus on what is unacceptable to us as a community in the current proposals.
- 2. Base your objection on something that you personally experience for instance, traffic delays or using the site for recreation. Don't generalise; stick to what you know and use examples from your own experience to illustrate your point.
- 3. Highlight specific concerns about how the application will affect the way you enjoy your property or go about your daily life. You don't need to exaggerate just be clear about what worries you. So, for example if you have respiratory illness and are worried about the impact of the dust, explain the potential impact on your daily activities when your breathing is bad.
- 4. If you know about specific events or incidents which you think might be relevant, give the details of these for example, local flooding or a problem on the road you use. If there are data sources that support what you know, refer to them.
- 5. Only certain things can be considered when the planning decision is made. This will include issues such as traffic, controlling dust and noise, flood risk, loss of habitat and how the land will be restored and used in the future. Try to keep your points focused on the impact of the application on the site and on Hamble rather than giving your views on wider concerns.
- 6. Don't go over the top. Your objection won't get more attention and it may obscure a good local point.
- 7. Remember that you'll be part of a cumulative effort to bring relevant issues to the attention of the County Council so don't feel the need to comment on every aspect of the application only those aspects which you believe will impact you.
- 8. Write your own objection. It's much better to give your own reasons than to sign a standard letter or petition.
- 9. There's no need to rush. You should aim to submit your response to the County Council by March 4 2022 but they will still accept representations after this date. Keep an eye on our website where we'll post regular information updates which might help. Taking a little time before you write might mean you can make your points more effectively.
- 10. You might also want to look at what other people have said in their responses to the application. You can do this by looking at the application online at https://planning.hants.gov.uk/Planning (Planning Application Reference: HCC/2021/0787).

NEW HAMBLE AIRFIELD FAQS FROM RESIDENTS

What is the exact type of vehicle proposed to be used by Cemex for moving material along Hamble Lane and what is the weight fully loaded?

We met with Cemex at the start of February and asked a similar question. They replied that they only use contractors whose fleet meet the Euro 6 Standard which limits the amount of harmful emissions produced by the vehicles. The trucks are 44 tonnes when loaded.

Is there an opportunity for a "Class Action" to be made on behalf of the whole village, using a significant law firm, skilled in tackling these planning applications and creating significant media attention? A law firm that is not intimidated at this level. Would a single "Class Action" offer a more focussed and heavyweight representation for current objectors, many whose focus may rely on a single issue?

Class Action isn't an appropriate tool for this situation. It would be used where there has been large scale loss or damage typically in situations such as breaches to competition law, data privacy and breach, financial services, shareholder, environmental, personal injury, and product liability claims. It would not relate to a statutory process such as planning, as this is mandated by national government, law, and guidance.

It may well be that we look to retain a QC at some point – especially if the application goes to Appeal for determination. However, at this stage there is a formal process to follow and there would only be grounds for a legal challenge if Hampshire County Council does not follow this process correctly. Any legal challenge would normally be in the form of a Judicial Review via the High Court.

Homes near the airfield will probably lose value as a result of the quarry. Could Cemex be asked / required to pay compensation for the fall in value?

I contacted the case officer at Hampshire County Council with your question and received the following response:

"With regard to your question on 'compensation', this is more a legal matter but in my experience I have never come across it in relation to the lawful issuing of a planning permission for any development where the proper processes have been followed. The planning system operates in a manner that ensures that all decisions ought to be made in the full cognisance of the relevant planning policies, consultee comments and local representations and in an open and public manner. The planning system aims to ensure that all decisions are made in the wider public interest and in accordance with the Local Plan and therefore compensation, in my opinion, is not something that will be available."

So I think the answer is no!

Where will the backfill be sourced from? What will it consist of? How are Cemex going to guarantee that materials used for backfill are completely free of toxins?

Cemex have told us that, should the application be approved, they will seek to enter into contracts with large infrastructure projects operating in the area that need to dispose of spoil. This is common practice. They will also look at a range of smaller projects to facilitate a regular flow of material back into the site as the restoration takes place.

All material coming to site would be subject to environmental permits and would be regularly checked and audited. As part of this process, Cemex would need to maintain a full audit trail of where infill has come from, what the material comprised, and where on the site it was used. The material would also be sampled when it comes to site to ensure it is free from contaminants.

The key to preventing any further development on the Airfield is NOT to make any improvements to Hamble Lane. How are these HGV trucks going to muscle their way onto a congested Hamble Lane? Will it be inevitable that we'll have install a roundabout or traffic liahts? Will the HGVS be avoidina shift/changeover hours from Hamble's commerce, and the school's entry/exit hours?

The transport assessment submitted by Cemex indicates that the majority of vehicles will be arriving and leaving the site in the morning, including during the period when children will be going to school.

NEW HAMBLE AIRFIELD FAQS FROM RESIDENTS

We are waiting to see the consultation response from the Highways team at Hampshire County Council as this will be a critical response.

We have also written to the Highways team separately to ask a number of questions and will share these when we have received a response.

Eastleigh Borough Council is retaining a transport consultant to look at the transport assessment and Hampshire County Council's response to it. We are working closely with them on this.

What is the District Director of Public Health's assessment of dust upon the school? Will the DDPH be liaising with the Blackthorn Surgery over Asthmatic cases?

Eastleigh Borough Council's Pollution Control Team have responded to the application as follows:

"At this time the Pollution Team are unable to ascertain from the information provided that potential significant adverse impacts from air pollution and noise will be avoided, and that adverse impacts will be otherwise minimised to acceptable levels. On this basis we are unable to support the application at this time."

What does it take to get an Independent Government inspector to review this application?

Hampshire County Council's Waste and Minerals Plan was subject to an independent review in 2013, and this sadly resulted in Hamble Airfield being allocated as a quarry for sand and gravel.

If Hampshire County Council reject the Planning Application from Cemex, the applicant has the right to ask the Planning Inspector to reconsider it.

Will this parkland be designated a 'Green Field Site' and/or a 'Green Belt' and can this be bound in legal contract? Once all these 20,000 trees are planted, will Persimmon Homes cut them all down to build houses?

The wording of the Waste and Mineral Plan for the restoration of the site is that it will provide a "combination of grazing, nature conservation, open space, public

access and woodland". We will be talking to Hampshire County Council about the use of both Section 106 agreements (which are specific to the development) and the use of Planning Conditions (that are attached to the land title) in an attempt to safeguard the Airfield from residential development post-quarrying.

The quarry is to be phased over 7 years and I doubt the community will accept the odd Christmas Tree that Cemex is proposing as compensation. What community gains has Hamble Parish Council requested?

In our response to the consultation exercise, we asked for the following:

Following restoration, the whole of the site should be set aside for public access and use, managed by a public body. The public has long enjoyed access across the whole site, and we would wish this to be protected and guaranteed going forward.

Cemex say the quarry will create 7 jobs, but at what cost to the village? What's the estimated number of businesses and jobs what leave the community as a result of this quarry?

Eastleigh Borough Council's Economic Development team has made the following comment:

"Cemex cites five principal economic benefits in its proposal: supplying the local construction industry with material, creating jobs, creating indirect spend in the local area through these new employees, paying business rates and a national aggregate levy. Of these, the locally sourced supply of construction material and the business rates revenue are the most compelling. The employment creation is low and the likely local spend correspondingly low whilst the national aggregate levy does not necessarily return to the local area. Increased travel movements on a single access road that already suffers from congestion is likely to lower the productivity of local commuters. On balance, the economic disadvantages appear to outweigh the benefits."

Hamble Parish Council will be issuing a business briefing to local businesses and have made a direct approach to a number of larger local employers, including Coopervision and BP.

NEW HAMBLE AIRFIELD FAQS FROM RESIDENTS

Are funds required to flight this application or mount a publicity/awareness campaign, like banners and leaflets etc?

Hamble Parish Council has set aside funds to respond to the application. We think there will be a need for a more active campaign once we get nearer to the application being considered by Hampshire County Council and are starting to think about how best to do this. We certainly would be happy to see local people and businesses helping with this stage of the campaign.

I use Hamble Airfield regularly to exercise my dog, along with many other dogwalkers. Could EBC designate the Airfield as a dedicated dog-walking park?

We know that many people have informally used this space over a long period of time and it is a valuable green asset for both people and wildlife.

We will be looking to do a survey of users of the airfield shortly to understand what the impact will be in terms of where people will go instead and how frequently.


In terms of a longer term approach to the site the Hampshire Waste and Minerals Plan states that after quarrying the site will be used as a "combination of grazing, nature conservation, open space, public access and woodland". This wording is also reflected in Eastleigh

Borough Council's emerging Local Plan. Hamble Parish Council has as part of its response to the first Cemex consultation in November 2021 asked that the site be passed over into public ownership with a view to safeguarding public access for the future. We will also be seeking a thirty year management plan for the site, as a minimum.

How can Cemex promise the land will be put back to recreational usage when it's not even their land – it's owned by Persimmon. Also, what happens if Cemex gets taken over or goes bust – how can they make promises for something that will happen in several years time.

The wording of the Mineral and Waste Plan states that the restoration of the site will provide a "combination of grazing, nature conservation, open space, public access and woodland". This will be secured by Hampshire County Council through the use of both Section 106 agreements (which are specific to the development) and the use of Planning Conditions (that are attached to the land title).

If Cemex were to cease trading their assets would be either be sold to another company with the restrictions in place or they would revert to the land owner which is Persimmon.



COMMUNITY NEWS

HAMBLE LOCAL HISTORY SOCIETY

At our February meeting, Toby Marris, Hamble resident and skipper of the 'Jolie Brise', gave an excellent and insightful presentation on the fascinating story of this



100+ year old sailing boat. Based in Hamble, it is arguably one of the most famous tall ships in the world. The 'Jolie Brise' is owned by the Dauntsey's School and she has taken up to twelve students for local and international cruising, as well as racing events since 1977.

Toby talked about the history of the 'Jolie Brise' that was built in 1913. He then explained about the Dauntsey's

School and how it acquired the 'Jolie Brise' in 1977 and became its owner. She has been based on the Hamble River since 1994 and has been as far north as the Arctic Circle, west to North America and south to the West African coast.

She is at sea approximately 200 days a year. During the winter months there are student working parties on the boat at Hamble to help maintain her in good condition. The boat has sometimes been used commercially to help cover costs, but this private work has reduced in recent years as it takes 15- to 25-year-olds on outreach work for other organisations.

Dauntsey's students have sailed her across the Atlantic six times and cruised Europe extensively. It is a great supporter and regular participant of the Tall Ships race that she has won four times.

WHAT TO DO IN YOUR GARDEN IN MARCH

The days are getting longer and sunnier, and summer is on the horizon! If you're lucky enough to have a small garden to enjoy, it's time to start doing one or two jobs to get it back into good order following the cold, dark days of winter.

Here's the Top 8 jobs to do in your garden in March, as suggested by the RHS:

- 1. Prune bush and climbing roses
- 2. Plant shallots, onion sets and early potatoes
- 3. Plant summer-flowering bulbs
- 4. Lift and divide overgrown clumps of perennials
- Top dress containers with fresh compost
- 6. Mow the lawn on dry days (if needed)
- Cut back Cornus (dogwood) and Salix (willow) grown for colourful winter stems
- Hoe and mulch weeds to keep them under control early

GLOBAL RECYCLING DAY: FRIDAY 18 MARCH



With Global Recycling Day nearly upon us, what can you and your family do to increase the amount of waste you recycle? Here's a few tips on where to start:

1. Check before you recycle

Many items such as textiles, electricals, pots and pans regularly end up in household bins. These items can be recycled but they need to be taken to your local Household Waste and Recycling Centre. If you're unsure how to recycle something, it's always best to check Eastleigh Borough Council's website.

2. Ensure recycling is empty, clean & dry

You don't need to scrub or sterilise your recycling, but items do need to be free from food residue. Rinse plastic tubs clean of leftovers and leave them to dry before placing them into your recycling bin for collection.

3. Remove plastic film

Plastic film can't be recycled, so make sure you always remove plastic film from bottles, plastic pots, tubs and trays before recycling.

4. Keep lids on plastic bottles

Lids are recyclable, but when they aren't screwed onto the bottle, they slip through the recycling machinery. To make sure all your lids are recycled properly, keep them on!

All the horses are made to order, finished with real hair, leather tack and name plates to personalise each one. The larger horses have cavities to accommodate a time capsule.
